1. Membership is non-refundable, may only be used by the registered users, and may not be reassigned to another person.
2. Membership is valid March 1, 2020 through February 28, 2021. Full payment is due at sign up and will not be prorated.
3. Member may play on all three courses at Eagle Crest Resort, unless noted above.
4. Member receives additional privileges and benefits detailed in the 2019 Golf Club Membership Overview.
5. Member may play from 8:00AM-8:30AM and 9:00AM-9:30AM, May 14 through September 30, 2020, on a space available basis.
6. Gold and Bronze Members may not play on the Sundays prior to Monday holidays, but may play on the Monday holidays.
7. Tee-time reservations may be made 16 days in advance by Platinum Members and 14 days in advance for all other Members.
8. Member may make one advance tee time per day. Additional same day rounds may be played on a space available basis.
9. Member will be charged the Owner greens fees rate for tee-times not cancelled 24-hours in advance.
10. Platinum Members receive one complimentary bucket of range balls per day. All other Members receive range balls at half price. Range balls and baskets are not to be removed from the golf facilities.
11. Member will acknowledge receipt of golf cart(s) in good working order and keep the cart(s) in the same condition. If a golf cart is not in good condition, Member agrees to return/refuse it and inform the golf-shop immediately. Member agrees to operate the golf cart(s) in a safe manner and comply with all signs, rules, requirements and directives from Eagle Crest and/or its personnel. Carts shall stay on maintained turf area's only and be kept a minimum of 20 yards from the edges of tees and greens. Carts are to stay on paths when directed. Member agrees to reimburse Eagle Crest for any and all damages (other than ordinary wear and tear) that occur during the time Member is in possession of/responsible for the cart(s). Member agrees to defend, indemnify and hold harmless Eagle Crest, its officers, agents, parent, and employees from any and all injury claims, including death and/or damage to any person/property arising from or related to the use/rental of golf cart(s). Member accepts full responsibility for the cart(s) and their actions while on the golf course.
12. Member guests will be charged the appropriate fees for golf cart use, even when accompanying a Member.
13. Member may obtain handicap flags in the golf shop with proof of medical condition or DMV Handicap Certification. Strict enforcement in effect for 2020. Special form available at the Golf Shop.
14. The above Membership prices and privileges are reserved for Eagle Crest property Owners. Non-Eagle Crest property Owner Golf Club Memberships are also available.
15. Eagle Crest reserves the right to cancel or modify the Memberships at anytime without notice.
16. Eagle Crest reserves the right to revoke the privileges of a Member, without refund, that violates any agreed condition above. Beginning in 2019 your current credit book value will be renamed "pre-paid" and these funds will continue to be available to you for all purchases thru December 31, 2020. If you do not spend your "pre-paid" balance by December 31st of 2020 the remaining balance will be donated to Eagle Crest Junior Golf. Any future winnings after January 1st, 2020 will be placed in your "credit book" account and these funds will be available only for golf shop merchandise purchases such as golf clubs, golf bags, clothing and golf miscellaneous items. Each year you will have until December 31st to spend the funds or donate the funds to Junior Golf.
